# 8. MISCELLANEOUS

a. Consideration, discussion and action on the City of Yale Municipal Pool 2019 Season. – Ms. Couch gave an update on the status of the pool for this coming season. No action was taken.

### 9. REPORTS FROM OFFICERS

- **a. Report from Police Chief:** Asst. Chief Moore reported that the department worked 19 cases, 2 burglaries which are now both solved and wrote 64 citations.
- **b.** Report from Fire Chief: Asst. Chief Bradley reported there were 18 calls for February, 1 rural structure fire, 1 mutual aid call, 2 motor vehicle accidents and a few medical assist calls. Two trucks are out right now getting fixed, the pump on Unit 900 is roughly \$4500 to get repaired and the pump valve on the backup engine is around \$1500 for the repair. ISO is still scheduled for April 23<sup>rd</sup>, hydrant testing is still going on. We have quite a bit of training going on right now as we have a young department. Josh would like to request a budget amendment of \$1,000 for fuel for the remainder of the fiscal year.
- c. Report from Library Director: Ms. Griffin reported she met with Mr. Kelly on the budget for the new year, e-rate funding for internet services has been submitted and centennial planning is going well. There was an essay contest for both youth and adults, the winners were in the paper. The summer reading program theme will be "Let's Celebrate". The library will be showing Small Foot next Wednesday during Spring Break. Summer classes are being scheduled and we are looking at scheduling Wednesday classes in April due to the number of kids that are at the library after school.
- **d. Report from City Manager:** Mr. Campbell reported the water repair on Boston has been concreted in and is back open. The vandalized stop signs have been taken down and replaced.
- **e. Report from City Attorney:** Mr. McMillian reported there was a meeting with Mr. Porter, Mr. Robinson, Mr. Kelly and himself. The lease purchase agreement that Mr. Robinson is proposing is not something that I Mr. McMillian is comfortable with. A request for an Attorney General's opinion has been sent through Senator Dugger, however the waiting time for a response is 6-12 months.

- **a.** Report from Commissioner Porter: Would like to commend the utility department on all they've done over the last month, keep up the good work.
- b. Report from Commissioner Strader: Nancy has done a lot of good work in the library, keep it up.

- **d. Report from Vice Mayor Welch:** We are 8 months into the year and there are projects that are not completed or even started. Next month would like a report on the cemetery plotting.
- **e. Report from Commissioner Baker:** Street lights are still out, the Bridge Club will be installing two benches in the big park by the playground, they'll be pouring concrete soon to anchor them to.
