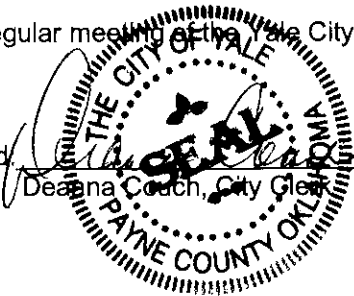
**OPENING PRAYER**
