3. **Consideration, discussion and action to authorize acquisition of Right of Ways for the construction of a natural gas pipeline to serve the City of Yale.** – Brian Porter, Jr. made the motion to authorize the acquisition of Right of Ways for the construction of a natural gas pipeline to serve the City of Yale. Mike Strader seconded the motion which passed as follows: Yea: Foutch, Brown, Porter, Strader, Welch Nay: None.
4. **Consideration, discussion and action to establish a maximum amount to be approved and authorized for the purchase of Right of Ways for construction of a natural gas pipeline to the City of Yale.** – The discussion for the acquisitions has been \$40 per rod with a \$1,000 minimum. Mr. McMillian explained the options the board had for the approval of acquisitions. Brian Porter, Jr. made the motion to approve \$50,000 to be encumbered for a new line item for acquisitions of Right of Ways, Jason Brown seconded the motion which passed as follows: Yea: Foutch, Brown, Porter, Strader, Welch Nay: None.
