


**MINUTES
YALE CITY COMMISSION
REGULAR MEETING
111 N. "B" STREET, YALE, OKLAHOMA
JANUARY 10, 2023
6:30 P.M.**

1. **CALL TO ORDER** – The regular meeting of the Yale City Commission was called to at 6:30 p.m. on Tuesday, January 10, 2023 by Mayor Jason Brown.
2. **ROLL CALL** – Those present were Brian Porter, Jr., Jason Brown, Larry Brown, Mike Strader and Richard Adsit.
