OPENING PRAYER – Opening prayer was led by Larry Brown.

- 1. CALL TO ORDER The regular meeting of the Yale City Commission was called to order at 6:30 p.m. on Tuesday, September 12, 2023 by Mayor Jason Brown.

- **4. ITEMS REMOVED FROM THE CONSENT AGENDA** Nancy Griffin made the motion to approve purchase orders 70016, 70037, 70059, 70073 and 70033. Brian Porter, Jr. seconded the motion which passed as follows: Yea: Strader, Griffin, Porter, Larry Brown Abstain: Jason Brown.
- 5. PUBLIC APPEARANCES Maurice Lozier discussed the city abatement procedures stating that if you don't have the right name in town then you don't get your property abated. He further stated that there was a list of property owners that could not be abated and asked how can you judge other people? Stacie Britton spoke stating the abatements should be stopped, tickets could be written for tall grass and the procedures were not right according to City Code.
 Roy Lozier spoke stating the City Commission does not do abatements to the legal letter of the law and that he is personally saving up funds to sue the City.

- c. Consideration, discussion and action on the property located at 305 N, Main Street. Jason Brown made the motion to extend the property abatement by 30 days and to have staff give a list of expectations to the homeowners. Brian Porter, Jr. seconded the motion which passed as follows: Yea: Strader, Griffin, Porter, Larry Brown, Jason Brown Nay: None.
- f. Consideration, discussion and action to contract with Ark Wrecking Company of Oklahoma for demolition and clean-up of the property located at 420 S. "B" Street in the amount of \$15,970.00. Staff requested to get bids from local vendors. Brian Porter, Jr. made the motion to table this item to the October 10, 2023 regular meeting. Larry Brown seconded the motion which passed as follows: Yea: Strader, Griffin, Porter, Larry Brown, Jason Brown Nay: None.
- g. Consideration, discussion and action on a Pole Attachment License Agreement with Vyve Broadband A, LLC. Jason Brown made the motion to approve a Pole Attachment License Agreement with Vyve Broadband A, LLC for \$2.50 per pole. Brian Porter, Jr. seconded the motion which passed as follows: Yea: Strader, Griffin, Porter, Larry Brown, Jason Brown Nay: None.
