# MINUTES YALE CITY COMMISSION REGULAR MEETING 213 N. MAIN STREET, YALE, OKLAHOMA JUNE 11, 2024 6:30 P.M.

# **OPENING PRAYER** – Richard Adsit

- 1. CALL TO ORDER The regular meeting of the Yale City Commission was called to order at 6:31 p.m. by Mayor Jason Brown.
- 2. ROLL CALL Those present were Brian Porter, Jr., Jason Brown, Karen Hart, Richard Adsit and Nancy Griffin.
- 3. CONSENT AGENDA Jason Brown requested to have purchase order 79008 removed and Nancy Griffin requested to have purchase order 79016 and 79049 removed. 5. PUBLIC APPEARANCES – Maurice Lozier stated the Southeast side of the water tower is overflowing. In 2009 a complete radio signal control system was installed to control all of the towers remotely. It should be in the armory which would help on water leaks.

Consideration, discussion and action to find the possible collapse, deterioration and damage to the roof of the Yale Armory building existing within the City of Yale, endangering the health and safety of persons and property within the City of Yale due to the danger to the public from such structure. Mr. Kelly discussed during the special meeting there were lost electric meters due to meters filling with water adding that the insurance company had agreed to pay for all the repairs. Mrs. Griffin stated that the building was a historical building and a part of our history and we needed to do what we could to preserve the few buildings we have left. Mr. Brown stated that regardless of the red tape, the repairs needed are an emergency and if the rain continues as it has been it could be devastating to the property. Richard Adsit made the motion to find the damage to the roof of the Yale Armory building within the City of Yale an emergency, endangering the heath and safety of persons and property within the City of Yale due to danger to the public from such structure. Brian Porter, Jr. seconded the motion which passed as follows: Yea: Adsit, Porter, Griffin, Brown Nay: Hart.
- b. Consideration, discussion and action on an operating agreement with Yale Youth Sports Association. Mrs. Griffin asked if the association provided the city with a calendar of events, Mr. Kelly stated we had received notifications from them in the past and we could request that again.
