**OPENING PRAYER** - Larry Brown led the opening prayer

- 1. CALL TO ORDER The regular meeting of the Yale City Commission was called to order at 6:29 p.m. on Tuesday, December 10, 2024 by Mayor Jason Brown.
- ROLL CALL Those present were Brian Porter, Jr., Jason Brown, Richard Adsit and Nancy Griffin; Karen Hart was absent.

Consideration, discussion and action on Resolution No. 18-2024 "A JOINT RESOLUTION OF THE CITY COMMISSION OF THE CITY OF YALE, OK, AND THE BOARD OF EDUCATION OF INDEPENDENT SCHOOL DISTRIC NO. 103 OF PAYNE COUNTY, OKLAHOMA, ALSO KNOWN AS YALE PUBLIC SCHOOLS, AUTHORIZING THE SALE AND CONVEYANCE OF CERTAIN REAL PROPERTY LOCATED IN THE CITY OF YALE, PAYNE COUNTY, OKLAHOMA, BY THE CITY OF YALE, OK TO YALE PUBLIC SCHOOLS AND AUTHORIZING YALE PUBLIC SCHOOLS TO ACCEPT SUCH TRANSFERS SUBJECT TO EXISTING USE RESTRICTIONS IMPOSED UNDER THE CITY'S LAND AND WATER CONSERVATION FUND GRANT. As well as the land and water conservation grants that were done in 1987 and 1983. The state will allow us to transfer or convey to the school and accept any remaining obligation of the city for those grants.
