OPENING PRAYER

- 1. CALL TO ORDER The regular meeting of the Yale City Commission was called to order at 6:05 on January 14, 2025 by Vice-Mayor Nancy Griffin.
- 2. ROLL CALL Those present were Karen Hart, Richard Adsit and Nancy Griffin. Brian Porter, Jr and Jason Brown were absent.

- 5. PUBLIC APPEARANCES Maurice Lozier stated with the cold snap coming in, worse than last year it would be appreciated for someone to open a shelter for the homeless and those with no utilities. He suggested building a shelter in the saferoom in lieu of the current building project that is being discussed. He also stated that the Police Department was writing citations to those who are driving law mowers for transportation. However, the City is hiring employees and giving them lawn mowers as transportation. He suggested redoing the City Ordinance and to stop hiring people without driver's licenses.

Ms. Hart stated she had watched the meeting she missed the previous month and was very disappointed that the expense had been approved.
